

LCA Board Mini Minutes Felice Gaddis, LCA Secretary

The Louisiana Counseling Association Executive Board held a hybrid meeting at the Golden Nugget Hotel and Zoom on October 12, 2024. Your board conducted the following business during the meeting:

- Division Pictures on LCA Website: Diane Austin, Executive Director, invited Division presidents to post their own pictures to their profile page on the website.
- PLPC Billing Review: Dr. Deatrice Green, PLPC Billing Committee, reported that Blue Cross and Blue Shield confirmed that PLPCs cannot yet bill independently. Dr. Green will share the supporting documentation once received.
- PLCA Division Restructure: Carrie Davidson, PLCA, announced that PLCA has accepted a strategic plan and goals, and has also appointed Andrea LeDee as President-Elect and LaTasha Richard as Treasurer. Ms. Davidson also announced plans to increase psychoeducation and support for PLPCs.
- ACACL Affiliate: Dr. Priscilla Delgado, ACACL President, announced plans to open a bank account as the last step to the affiliate becoming an LCA Division.
- Brown and Felice Gaddis, Government Relations ad -hoc Committee, shared ideas to increase participation at Day at the Capitol this spring, and shared supporting documents for the new Government Relations positions. A motion to accept the GR Specialist job description and evaluation passed. A motion to accept the Advocacy Specialist job description and evaluation also passed.
- Membership Project: Dr. Kelle Falterman, President Elect-Elect, announced that the school with the highest percentage of students with LCA membership will receive five free student registrations for the LCA Conference 2025. The deadline to compete ended during the Conference.
- Social Media: Arkeria Robertson, Assistant Digital Media, reported seeing increased views and shares (Mini-Minutes continued on page 4)

Government Relations Update

The recent Louisiana Counseling Association (LCA) annual conference brought a surge of insights, discussions, and progress for the counseling profession. A significant highlight of the event was the active involvement of LCA's Government Relations Committee, which has been working tirelessly to advance the interests of counselors and protect the integrity of the profession statewide. Here's a summary of the committee's activities, including an update on the Counseling Compact and the annual Government Relations Town Hall.

Progress on the Counseling Compact

A central focus of this year's Government Relations Committee efforts was the progress surrounding the Counseling Compact. For those unfamiliar, the Counseling Compact is an interstate agreement that allows licensed counselors to practice across state lines without the need for additional licenses, provided their home state is part of the compact. This initiative aims to increase accessibility to mental health services and streamline processes for counselors who wish to work in multiple states.

Louisiana has been an active proponent of the Counseling Compact and was an early adopter of the legislation, recognizing its potential to address gaps in mental health access and improve service delivery. The Counseling Compact Commission has been working hard to develop a database to manage the compact relay of information from state to state and it is anticipated that counselors will be able to apply for a privilege to practice in other Compact states beginning in mid-2025. - conference-Related Reports: Austin White, Business Manager, announced an amendment to the budget for the Conference. The motion to accept the new budget passed. Nikki Lee, People's Committee, shared a land acknowledgment and LCA's JEDI statement during the Conference. Diane reported that voting for the President Elect-Elect -Elect would take place via the LCA App and announced during the Conference.
- Division Needs for Conference 2025: Diane reported that conference related requests from all Divisions must submit by February 2025 to be ready for 2025 Fall Conference in Baton Rouge.
- Announcements: Dr. Vicki Guilbeau, LCA President, announced the addition of multicultural CEUs for licensure, three for LPCs and 1.5 for PLPCs, will go into effect April 1, 2027.

to be a cornerstone event at the LCA conference, giving counselors an opportunity to voice their concerns, ask questions, and learn about legislative developments that affect their work. This year's town hall was particularly engaging, with participants discussing both state and federal policies impacting counseling practices, reimbursement rates, and licensure requirements.

Several key topics were addressed:

- 1.Counselor Medicaid Reimbursement— Members discussed the need for advocacy around fair reimbursement rates and ensuring that counselors receive equitable compensation compared to other mental health professionals and surrounding states.
- Mental Health in Schools An ongoing area of interest is expanding access to counseling services within
 the school system and managing recent legislation
 within the school systems.

Throughout the town hall, committee members encouraged counselors to stay engaged with their repre-

sentatives, noting that sustained grassroots advocacy is essential to achieve long-term legislative success.

Moving Forward: How to Stay Involved

As the Government Relations Committee looks forward to another productive year, they emphasized the importance of collective advocacy. Counselors are encouraged to participate in upcoming meetings, stay informed on legislative developments, and reach out to policymakers about the issues impacting their profession.

The LCA Government Relations Committee thanks all participants for their continued dedication to advancing the counseling field in Louisiana. With everyone's involvement, the committee remains optimistic about what can be accomplished in the coming year. What is LCA's Election Process?

Some of you might be wondering how the election process works. In the past,



LCA has tried various methods such as publishing ballots in the Lagniappe and paper ballots at conference for members to cast votes. Therefore, members could either vote during the annual conference or mail in their ballots. The LCA Executive Board realized a potential problem with paper ballots was the ability for non-members who attended conferences to cast votes or for members to vote multiple times. In full transparency, LCA recently received questions as to whether multiple voting occurred; however, LCA verified that there was no indication that voting was comprised. In fact, for 2024, the LCA Executive Board decided to adopt electronic voting hosted by ESX, LCA's website provider, for a more streamlined and secure process. ESX's process ensures that only members can access the voting platform and that members can only access the voting system once. Special election procedures may apply in the event of a runoff. LCA is dedicated to equitable voting and encouraging members to vote in general.
